All-State Orchestra 2020-2021 Registration

Georgia All-State is a special event organized by the **Georgia Music Educators Association (GMEA)** and allows high caliber students from all over the state to work together with nationally renowned conductors in music education. The 3-day event is held in Athens, Georgia, from April 15-17, 2021. Students must undergo two separate auditions and will be selected performance merit based on performance technique and musicality.

The first audition is held at the district level and students must pass with a minimum score of 55 out of 80 to proceed to the second round. In the second-round audition, middle school orchestra students are competing against other middle school students at the state level. Students are ranked based on their second-round audition performance scores which determines their selection into the Georgia All-State Orchestra.

Most students who plan to audition for Georgia All-State should have a private lesson teacher as the music requirements go beyond the scope of Middle School Orchestra curricular standards. It is up for the private lesson teacher to determine if a student should audition for Georgia All-State.

The fee to register for students wanting to tryout of All-State is \$25, due by October 16, 2020

2020-2021 Audition Dates and Locations

- First Round Audition: December 5, 2020 (Virtual)
 - *students accepted in All-State Orchestra Spring 2020, are exempt from the 1st round audition this fall*
- Second Round (final) Audition: February 13, 2021 (Virtual)
- All-State Orchestra Event: April 15-17, 2021 Classic Center Athens, Georgia

Virtual Auditions and GMEA Refund Policy

Virtual Auditions

Currently, no directions or details were given to orchestra directors regarding "Virtual Auditions." Information will be shared to students immediately once orchestra directors receive information from GMEA.

Refund Policy

No refunds of All-State registration fees can be given regardless of reason including cancellation or failure to appear for auditions. Please be advised that refund policies are dictated by GMEA and not by River Trail MS or Fulton County Schools.

Orchestra Enrollment Policy

GMEA policy requires that students must be enrolled in their school's orchestra program during the registration, audition, and acceptance for All-State Orchestra. Directors are required to notify GMEA immediately if a registered student leaves the program.
