## All-State Orchestra

### 2023-2024 Registration

Georgia All-State is a special event organized by the **Georgia Music Educators Association (GMEA)** and allows high caliber students from all over the state to work together with nationally renowned conductors in music education. The 3-day event is held in Athens, Georgia, from February 29 – March 2, 2024. Students must undergo two separate auditions and will be selected performance merit based on performance technique and musicality.

The first audition is held at the district level (face2face) and students must pass with a minimum score of 55 out of 80 to proceed to the second round. In the second-round audition, middle school orchestra students are competing against other middle school students at the state level. Students are ranked based on their second-round audition performance scores which determines their selection into the Georgia All-State Orchestra.

Most students who plan to audition for Georgia All-State should have a private lesson teacher as the music requirements go beyond the scope of Middle School Orchestra curricular standards. It is up for the private lesson teacher to determine if a student should audition for Georgia All-State.

**The fee to register for students All-State Auditions is \$26, due by August 28, 2023**

- **First Round Audition:** October 15, 2022 *at Autry Mill Middle School*
- **Second Round (final) Audition:** January 14, 2023 *at Westminster Schools*
- **All-State Orchestra Event:** March 2-4, 2023 *Classic Center - Athens, Georgia*

#### **All-State Policies**

##### **Registration Fees**

Fees must be paid through the by the All-State Registration Deadline – August 28, 2023. You may make payments on the RTMS Online Payment platform *found* on River Trail Middle School’s website titled “*Orchestra-All-State Registration*”

##### **Refund Policy**

Once the registration deadline has passed, no refunds of All-State registration fees can be given regardless of reason including cancellation or failure to appear for auditions. Please be advised that refund policies are dictated by GMEA and not by River Trail MS or Fulton County Schools.

##### **Orchestra Enrollment Policy**

GMEA policy requires that students must be enrolled in their school’s orchestra program during the registration, audition, and acceptance for All-State Orchestra. Orchestra Teachers are required to notify GMEA immediately if a registered student leaves the school orchestra program.

#### **First Round Audition Requirements: Middle School**

Students are required to play two All-State Scales, the All-State excerpt for first round auditions, and one sight-reading excerpt. You may find the required All-State Scale list and the Excerpt through the link below:

1. Fee registration of \$26, **needs to be paid online through the RTMS Online School Payment platform by August 28, 2023**  
**Payments and Forms after the deadline will not be accepted.**
2. Forms must have the OSP receipt number to be accepted and processed.
3. No refunds of All-State registration fees can be given after the registration deadline regardless of reason, including cancellation or failure to appear at the auditions.
4. It is the responsibility of the student to check they are practicing the correct etude for the 1<sup>st</sup> round auditions. No extensions or retry is given for students who practiced the wrong, required etude.
5. It is the responsibility of the student to check the **FINAL All-State Registration list posted in class on August 30**. Students **must immediately notify Mr. Liu** of any errors (*missing name, misspelled name, wrong grade, incorrect instrument, etc.*) by the specified deadline date on the Final Registration List.
6. It is **IMPORTANT** that students notify Mr. Liu of any errors listed in (#5) – **especially if a student's name was not on the list**. Mr. Liu will be **unable to register students** after the All-State Registration is sent to GMEA - **even if the registration form and fee were turned in on time**.
7. Students who pass the 2nd (Final) Round Audition must make their own transportation, hotel, and meal accommodations for the week of the All-State event. In addition, the student must have an adult chaperone for the duration of the trip.
